1	TBEA CO. Ltd.	Bidder has submitted a Construction Schedule of 43.6 Months (1307 Days) instead of 1080 days. Hence, the bid submitted by bidder has been considered non responsive as per ITB clauses 6.4,11.2 h), 17.1, 30.1(a)(b)&(c), 32.2, 32.2(a) & 32.2(b) and 32.4 of Section 1 of the Bidding Document.
2	Sinohydro Corporation Ltd.,	Project has request clarification on Section III: EQC 2.4.2, Specific experience (a), as per ITB 29.1, however the Bidder did not respond within last date of clarification submission date. Hence, the bid submitted by the Bidder was found to be non-responsive pursuant to "Clarification of Bid, ITB clause 29.2, "Non material non conformities", ITB Clause 33.2 of the Bidding Document.
3	Aster Jyoti JV	The price bid submitted by Aster Jyoti JV found open inside technical bid without envelop in a file. The same was recorded in the record of Technical bid opening. The Bidder disclosed the bid price by including letter of price bid and summary of price schedule in the technical bid. Hence bid submitted by bidder has been considered non responsive as per ITB Clause 27 and bid was rejected pursuant to ITB Clause 27.8 of the Bidding Document.
