 - Minimum Work experience of similar size and nature: **1 number of project and with minimum of NRs 2,98,18,811.00 value of the project]**
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 on 31st days of notice publication date at the office of NEA, Marsyangdi-Kathmandu 220 kV Transmission Line Project site office, Matatirtha, Kathmandu, Nepal. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 11,20,000.00, which shall be valid for 30 days beyond the validity period of the bid .
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
